## MidFirst Bank 2025 Ultimate Game Day Experience Sweepstakes Official Rules

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN THIS SWEEPSTAKES. A PURCHASE OR PAYMENT WILL NOT INCREASE OR IMPROVE YOUR CHANCES OF WINNING.

**ELIGIBILITY.** The Ultimate Game Day Experience Sweepstakes (the Sweepstakes) is only open to entrants who, as of the entry date, are permanent legal residents of Oklahoma who are at least eighteen (18) years old. The Sweepstakes is void outside the eligible Sweepstakes territory and where prohibited or restricted by law. Employees, officers and directors of MidFirst Bank (Sponsor) and its parents, subsidiaries, and affiliates, including, without limitation, divisions, advertising and promotion agencies and the immediate families (defined as parents, spouses, children, siblings, grandparents and their respective spouses) or members of the same household (whether related or not) of each such employee, officer and director, are not eligible to enter. The Sweepstakes, and any website pages and advertisements relating thereto, is intended for viewing only within the eligible Sweepstakes territory, and entrants must be present in the eligible Sweepstakes territory at the time they enter. To be eligible for the Thunder Basketball Ultimate Game Day Experience Sweepstakes, entrants must live within a 150-mile radius of the Paycom Center in Oklahoma City, Oklahoma.

**TIMING.** The Sweepstakes consists of two (2) Entry Periods, the "Football and First Thunder Drawing Entry Period" and the "College Basketball and Second Thunder Drawing Entry Period," defined below.

- For entry into the "Football and First Thunder Drawing," entries must be received between 12:00 a.m. Central Time (CT), September 1, 2025, and 11:59 p.m. CT, October 24, 2025 (the "Football Entry Period").
- For entry into the "College Basketball and Second Thunder Drawing," entries must be received between 12:00 a.m. CT, October 25, 2025, and 11:59 p.m. CT, December 31, 2025 (the "Basketball Entry Period").
- Sponsor's computer is the official timekeeping device for the Sweepstakes. Collectively, the Football Entry Period and the Basketball Entry Period are referred to herein as the "Entry Periods" or individually as an "Entry Period."

**HOW TO ENTER.** There are two (2) ways to enter the Sweepstakes:

ENTRY USING DEBIT/CREDIT CARD TRANSACTIONS. To enter using a MidFirst Bank debit or credit card, entrants must register their MidFirst Bank debit or credit card for the OU®, OSU, UCO, TU or Thunder Team Experience, and must use their registered debit or credit card to make purchases during the applicable Entry Period. Each purchase that is posted during the applicable Entry Period (defined above) will earn one (1) entry into the drawing for the Team Experience of the entrant's choice, subject to the limits on entry described below. To register a MidFirst Bank debit or credit card, entrants must visit <a href="midfirst.com/game-day-ok">midfirst.com/game-day-ok</a> during the Entry Period, complete the online registration form and submit it in accordance with the on-screen instructions. A debit or credit card must be registered to be eligible for entries into the Sweepstakes. Each debit or credit card may be registered for only one (1) Team Experience. If at any time during the Sweepstakes Entry Period an entrant chooses to reregister a previously registered MidFirst Bank debit or credit card for a different Team Experience, previous purchase-related entries will not be counted toward the new Team Experience selection, and the entrant will no longer be registered for the originally selected Team Experience. Only debit cards tied to consumer checking accounts and consumer credit cards are eligible for registration into the Sweepstakes. Debit cards tied to MidFirst Bank business accounts are not eligible for registration.

**ENTRY BY MAIL**. To enter by mail, entrants must hand print the following information on a 3 x 5 inch piece of paper and send it by United States mail during the applicable Entry Period in a sealed envelope no larger than 9 1/2 x 4 1/4 inches (a #10 envelope) with correct postage to Ultimate Game Day Experience Sweepstakes – Entry, c/o MidFirst Bank, P.O. Box 26750, Oklahoma City, OK 73126-0750: full name, complete home address, day and evening phone numbers, email address, age and Team Experience of your choice. All mail entries must be received by Sponsor during the applicable Entry Period outlined in the "**Timing**" section above. No facsimiles, photocopied or mechanically reproduced entries are allowed. Use of any automated system to submit entries is prohibited and will result in disqualification. Each mail entry may be directed to only one (1) Team Experience. If at any time during the Sweepstakes Entry Period an entrant enters a drawing for another Team Experience, all previous entries will be forfeited and will not count toward the new Team Experience selection, and the entrant will no longer be registered for the original Team Experience.

LIMITS AND CONDITIONS FOR ENTRY. Entries in the Sweepstakes are limited to five hundred (500) entries per debit or credit card (regardless of method of entry) or address (mailing). All entries, regardless of method of entry, must be received by Sponsor during the applicable Entry Period. All entries become the exclusive property of Sponsor, and none will be acknowledged or returned. Proof of mailing or online submission will not be deemed to be proof of receipt of entry by Sponsor. All entrants and entries are subject to verification prior to the awarding of a prize, as are the eligibility, age and other claims of information provided by a potential prizewinner. Entrants will cooperate with Sponsor and its representatives in connection with any and all verification activities.

**AGREEMENT TO OFFICIAL RULES AND DECISIONS.** By participating in the Sweepstakes, each entrant fully and unconditionally agrees to be bound by and accepts these Official Rules and the decisions of Sponsor (including, without limitation, decisions regarding eligibility of entries, the selection of entrants and the winner, and the awarding of the prize), which are final and binding in all respects.

DRAWING, ODDS AND NOTIFICATION. This Sweepstakes consists of the "Football and First Thunder Drawing" and the "College Basketball and Second Thunder Drawing," each of which offers entrants the chance to win the respective prize (defined below) for the entrant's registered Team Experience. Immediately following the end of each Entry Period (10/25/25 for the Football Entry Period and 01/1/26 for the Basketball Entry Period), Sponsor will randomly select a potential winner from among all eligible entries received by Sponsor through all methods of entry for each Team Experience. Odds of winning a prize depend on the number of eligible entries received by Sponsor for each Team Experience in the Sweepstakes. Each entrant selected must comply with all terms and conditions of these Official Rules, and winning is contingent upon fulfilling all requirements. Each potential winner will be notified by phone, mail, courier and/or email. Each potential winner will be required to execute and return to Sponsor a notarized Affidavit of Eligibility, a Liability Release, and except where prohibited by law, a Publicity Release (an Affidavit/Release) in the form(s) provided by Sponsor in order to claim his/her prize. The Affidavit/Release must be returned to Sponsor by the date and/or time indicated within the Affidavit/Release. If a potential winner cannot be contacted within forty-eight (48) hours of the first attempt to contact him/her, or if a potential winner fails to return the Affidavit/Release within the specified time, or if any prize or prize notification is returned as undeliverable, or if a potential winner is found to be ineligible, or if a potential winner does not comply with the Official Rules, then the potential winner may be disqualified and an alternate winner selected by Sponsor in his/her place at random from among all eligible non-winning entries received by Sponsor for the Sweepstakes. In such event, an alternate potential prizewinner will be notified as described above and will be required to return the required documents to Sponsor as described above; provided, however, Sponsor may alter the above timing to meet its Sweepstakes schedule and due to such schedule, Sponsor may be unable to award the prize in this Sweepstakes.

- e) One (1) Thunder basketball-themed Experience valued at one thousand five hundred dollars (\$1,500).

## The College Basketball and Second Thunder Drawing Entry Period

- f) One (1) OU® Basketball Experience valued at one thousand one hundred dollars (\$1,100),
- g) One (1) OSU Basketball Experience valued at one thousand one hundred dollars (\$1,100),
- h) One (1) TU Basketball Experience valued at seven hundred dollars (\$700), and
- i) One (1) Thunder basketball-themed Experience valued at one thousand five hundred dollars (\$1,500).

Each experience prize package shown above includes one (1) five-hundred-dollar (\$500) Visa® Gift Card, four tickets to attend the applicable football or basketball game at a date and time selected by Sponsor in its sole discretion, and other goods, services and/or experiences, the total of which are valued in the amounts described above.

Each prize is non-transferable, non-assignable, nonnegotiable and not redeemable for cash or credit. Each prize must be accepted as awarded. Each prize is awarded AS IS with no warranty, representation or guarantee, express or implied, in fact or in law, made by Sponsor or for which Sponsor shall be liable, including, without limitation, ANY IMPLIED WARRANTIES OF MERCHANTABILITY, NON-INFRINGEMENT OR FITNESS FOR A PARTICULAR PURPOSE. There will be no prize substitutions, except by Sponsor, who reserves the right (but has no obligation) to substitute a prize (or a component thereof) with another prize of equal or greater value (including cash) if the prize (or a component thereof) is not available for any reason as determined by Sponsor in its sole discretion. Unused components of each prize shall be forfeited and have no redeemable cash value. Each winner is solely and fully responsible for any and all costs, fees, taxes, assessments and expenses associated with each prize award, redemption, receipt and use, including, without limitation, all federal, state and local taxes on the prize. If applicable, each winner will be issued an IRS Form 1099 for the actual retail value of the prize. Winners waive the right to assert as a cost of winning a prize, any and all costs of verification and redemption or travel to redeem the prize. Noncompliance with any of the foregoing and any other condition of this Sweepstakes may result in disqualification and forfeiture of prize, in which case, no consideration will be awarded. Sponsor reserves the right, in its sole discretion, to disqualify any individual it finds to be tampering with the entry process or the operation of the Sweepstakes, or to be acting in violation of these Official Rules or in an unsportsmanlike or disruptive manner. DISPUTES.
